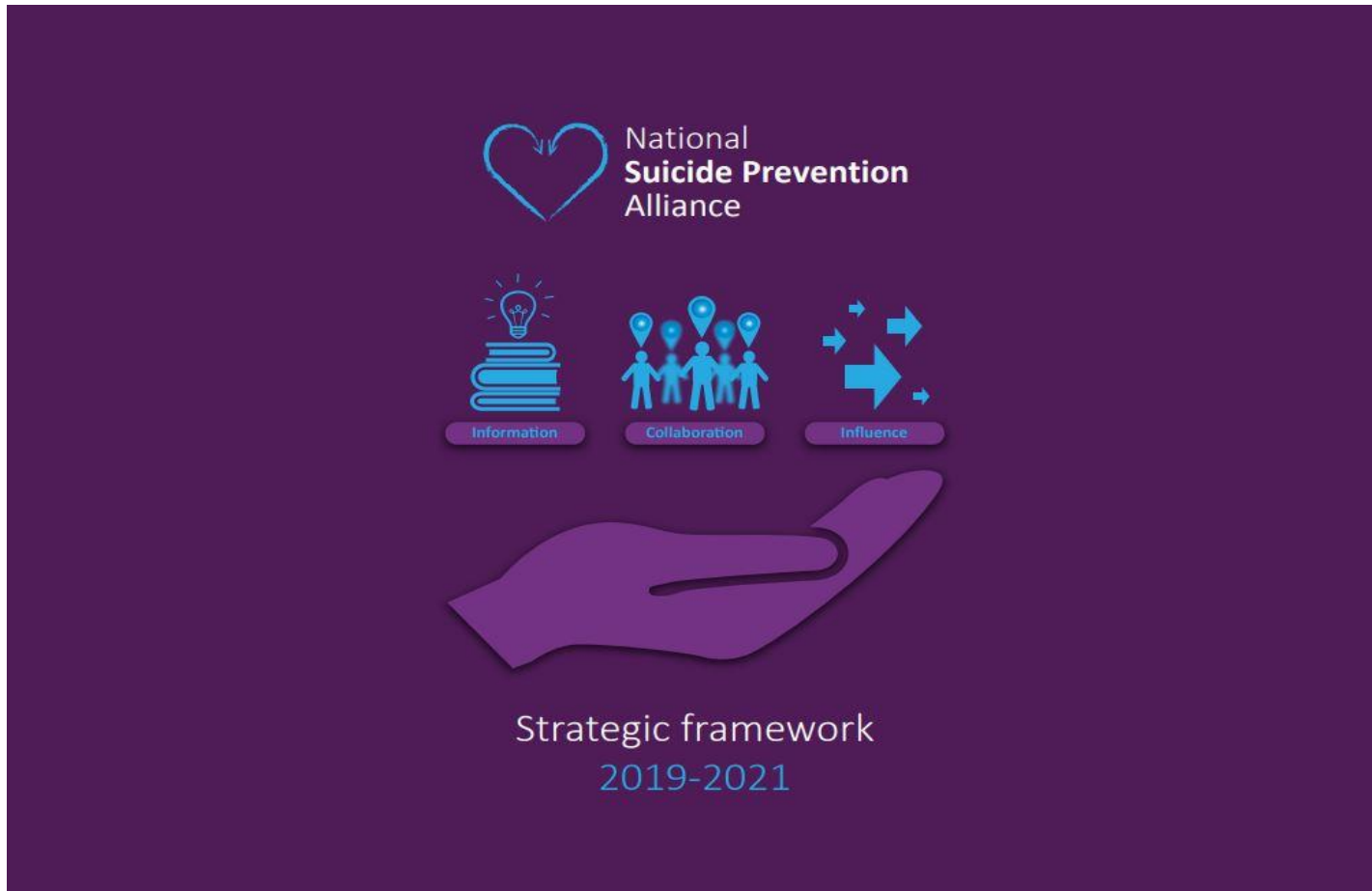

- ♡ *Newsletter reaching 1000 people each month*

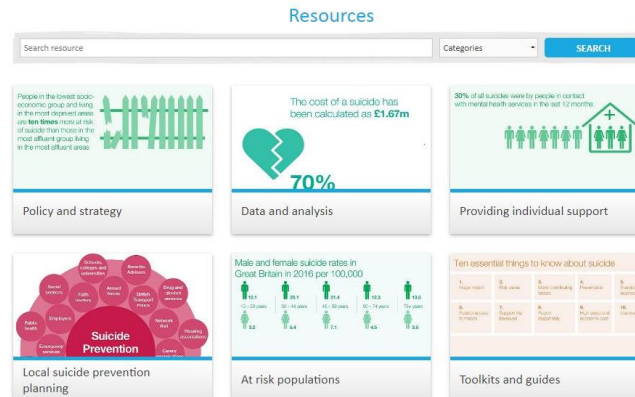
